

Opening of the Selection Process for ENA and IRA Long-Term International Courses: October 6th, 2021

Senior official, you want to improve your skills, develop new know-how directly linked to your missions, discuss with senior officials of public administration around the world ?

As of January 1, 2022, the ENA will become the INSP. The international dimension of ENA will be further asserted with the future National Institute of Public Service, which will have the following objectives:

- The European and international influence of the French model of administration in the context of the rapid and profound changes in the country, and in an increasingly complex European and international environment.

- The ability to build partnership projects with an international dimension involving a wide variety of high-level players from various backgrounds.

- The strengthening of links between public policies and research and the academic world, at national and international level will be widely promoted.

- Openness of senior French officials to European and international issues

Each year, ENA selects around 70 candidates for its long-term international courses and those of the Instituts Régionaux d'Administration (IRA).

3 long-term courses are open to foreign public agents and civil servants

Long International Course (CIL)

Lasting 13 months + 1 option month open to junior civil servants or public agents. The CIL may be open to future civil servants after dispensation.

■ This course leading to ENA International Certificate in Public Administration can be completed with one of the three high-level professional Masters programmes : a Masters programme in General Public Administration, a Masters programme in Public Institution Communication and a Masters programme in Public Action in Europe organised by ENA in partnership with prestigious French universities: University Paris IV CELSA ; University Paris 1 Panthéon-Sorbonne, and the University of Strasbourg.

NB : French nationality debar candidates from long international course.

International Advanced Training Course (CIP)

Lasting 8 months, open to senior civil servants.

■ This course leading to ENA International Certificate in Public Administration can be completed with a Masters programme in one of two special areas: "Public Administration and international affairs" or "Public Specialised Administration" organised in partnership with University Paris 1 Panthéon-Sorbonne, and the University of Strasbourg.

IRA International Course (CiIRA)

Lasting 8 months, open to junior and senior civil servants.

■ This diploma training specifically dedicated to executives intermediaries and high potential foreign administrations takes place at within one of the five Regional Institutes Administration (IRA). Listeners CiIRA are fully integrated into the promotion of trainee attachés. The CiIRA can also be supplemented by obtaining a master's degree in universities IRA partners.

For ENA cycles, interested candidates must exercise higher level responsibilities in the administration, be perfectly French-speaking, be fluent in English and have a master's level 1 or equivalent.

For the CiIRA, interested candidates must exercise intermediate level responsibilities in administration, be perfectly French-speaking, and have a bachelor's degree or equivalent. The selection procedure is common to the cycles of ENA and IRAs.

The selection process is the same for ENA and IRA courses.

■ Selection of candidates on file (by ENA) between **22th November to 3rd of December 2021**

■ Transmission to the embassies of the list of candidates to be invited to writings between the **6th and 17th December 2021**

■ Written examinations organized from **10th to January 16th 2022** by the services embassies.

■ Oral tests organized from **14 March to April 8, 2022** by the services embassies.

■ Final selection committee : **May 2022**.

■ The start of the IRA cycle and CIL is scheduled for **September 1 2021**.

■ The start of the CIP is scheduled in **December 2022**.
